Video Conferencing Services

With the Corona virus forcing many people to stay home and telecommute some of the video conferencing companies are offering reduced rates or free services. Below are some options including links to the reduced rates:

1. <u>Zoom Basic</u> – Free – Meetings for a limited number of participants for up to 40 minutes.

2. <u>Zoom Pro</u> – \$14.99 per month – Up to 100 participants per meeting. No time limit. (Zoom is available Free for educational use – https:// blog.zoom.us/wordpress/2020/03/13/how-to-use-zoom-for-onlinelearning/.

3. <u>Google Meet</u> – Free – Restrictions vary based on whether they are usng Google Suite or regular Gmail as a host account https:// cloud.google.com/blog/products/g-suite/helping-businesses-andschools-stay-connected-in-response-to-coronavirus.

4. <u>Cisco WebEx</u> – Free during the Pandemic – https:// help.webex.com/en-us/n80v1rcb/Cisco-Webex-Available-Free-in-These-Countries-COVID-19-Response.

5. <u>Microsoft Teams</u> – Microsoft has tools within their MS Teams platform, both for paid and free users available as part of their response to the pandemic – https://www.microsoft.com/en-us/microsoft-365/ blog/2020/03/05/our-commitment-to-customers-during-covid-19/.

If you choose to use a video conferencing service remember your etiquette! Here are a couple of tips and tricks to help your meeting go smoothly!

• When you are not actively talking mute your mike!

This can help cut down on feedback and help everyone hear the person speaking.

- Keep your camera on if you are using the computer! It might sounds silly but it is nice to see everyone's smiling faces.
- If you are not comfortable speaking or your mike will not connect most services have a chat option.
 - I am not familiar with all of the conferencing services above but most have a chat option that is easy to use. You can message the whole group or individuals.
- Some of the above services offer recording options.

If not everyone can meet but you don't want to forget what you discussed there are recording options! I know that Zoom has this option. 4-H Club and Project Leaders
