
In Person Meeting Approval Process

Animal Projects:

Attention new market animal families! It may not seem like it but fair prep is just beginning! I have a couple of dates and tips for families to remember as the fair prep begins.

Beef:

Superintendent-Kent Haake 608-582-2291

- If you are planning to show a market steer they have to be weighed in and have corresponding tags from the weigh in. This is important as you may have difficulties showing come fair time if this step is missed.
- Beef weigh in is on February 13th from 10-12 am at the Independence NFO.

Sheep:

Superintendent- Jason Hovell 608-534-0024

- Market sheep will also need to be weighed in. Sheep weigh in is typically in April.
- Sheep also require a weigh in and ear tag
- I have not seen a date yet for this day but

Swine:

Superintendent-Jamie Goplin 715-530-0875

- Swine **DO NOT** have to be weighed in for biosecurity reasons. This is a common questions every year and it is most likely not going to change.
- Swine **DO** need tags. There are emails that will come out from the fair board giving you these details as I don't have them.

I don't have all of the current information yet but I will give updates as I get them.

Where to Find up Coming Programs:

With the sear mass of virtual programs coming out all around the state, which any youth in the state of Wisconsin can participate in, it is hard to keep up with them. I know sometimes there are not as many programs listed here in the newsletter but there are more on Facebook, that is the reason. I try to watch for what the state , local counties and area programs are sharing so I can pass this message along to you guys. Some of these programs are not quite newsletter worthy but they are still great opportunities for the members in our county.

Bruce Mound Ski Trip:

The Leaders Board is planning a Ski trip this year! There will be registration coming out quickly we just don't have it ready yet. We are planning for a Saturday evening in the upcoming weeks so keep your eyes peeled for an email from me letting you know how to register. Even though this is an outdoor activity we will be **requiring masks for this event**. This is to prevent the spread from members touching common surfaces. Sanitizer, cleaning solutions will also be provided to help supplement as well.

VIP Training:

VIP or volunteers in preparation training is for anyone who wants to work with youth one-on-one and teach sessions like a project or club leader. If you have signed up to be a volunteer in 4-H Online and I have not approved you yet it might be because of this. Look for this symbol . This means that you will need to complete either VIP or mandated reporter training. Mandated reporter is an online course in 4-H Online that you can complete on your own time. VIP however, has to be taught by either myself or another educator either virtually or in person. This training covers many top-ics on how to create a safe environment for youth and takes about 90 minutes.

I prefer to do VIP trainings on weeknights in the winter because the rest of the year gets pretty busy for everyone especially in the summer.

4-H Online 2.0:



The winning flavor, Tractor Tracks, features chocolate ice cream, peanut butter cups and a marshmallow swirl.

According to Brenda Scheider, Executive Director of the Wisconsin 4-H Foundation, the contest is a great opportunity for 4-H youth to work together to develop and name their flavor. "The most exciting part of the contest is the winning flavor will be available through Cedar Crest this summer."

The annual contest has already yielded popular flavors including Wisconsin Campfire S'more created by Springbrook 4-H Club of New Richmond; Deep Woods, created by the Badger Boosters 4-H Club of West Bend; and Deep Space, developed by the Baraboo Valley 4-H Club.

Says Cedar Crest President, Ken Kohlwey, "We are proud to support the Wisconsin 4-H organization through our annual flavor contest. The project requires collaboration, teamwork and creativity to create the next best ice cream flavor. We look forward to reading each entry that comes in and share the winning flavor with our customers."

A panel of ice cream experts chosen by Cedar Crest judged the entries. The company manufactures more than 80 flavors of ice cream, along with frozen custard, gelato and sherbet at its Manitowoc, Wisconsin, plant, and distributes products in five states. Many of the flavors now produced by Cedar Crest, like Wisconsin Campfire S'more, are a result of the contest.
